

**MEMORANDUM OF UNDERSTANDING
BETWEEN
GRANTHAM UNIVERSITY
AND THE
DEFENSE ACQUISITION UNIVERSITY**

1. PARTIES. The parties to this agreement are Grantham University (hereinafter referred to as GU) and the Defense Acquisition University (hereinafter referred to as DAU).

a. Grantham University (GU) is a private nationally accredited distance learning university established in 1951 offering undergraduate and graduate degree granting programs in Criminal Justice; Business Administration; Computer Science; Computer Engineering Technology; Electronics Engineering Technology; General Studies, Interdisciplinary Studies; Master of Business Administration (MBA); MBA Information Management; MBA Project Management; Master of Science Information Management Technology; Master of Science Project Management; Master of Science Information Technology.

b. The Defense Acquisition University (DAU) is the sole institution that engages with nearly every member of the Department of Defense Acquisition, Technology, and Logistics (AT&L) workforce – approximately 134,000 individuals - throughout all professional career stages. DAU provides a full range of basic, intermediate, and advanced certification training, assignment-specific training, performance support, job-relevant applied research, and continuous learning opportunities.

2. PURPOSE.

a. Grantham University is committed to serving working professional adult students with dynamic and relevant higher education by providing learning methodologies that access a wide range of degree programs in ways and at times that are accessible and provide the student with a significant degree of control over both course and degree program completion. In enabling the student, GU's student centered, learning based academic model is concentrated in on line faculty who are focused on academic accountability.

b. Defense Acquisition University strategically partners with academic institutions, professional organizations, corporations, and government agencies to provide professional development, equivalencies, academic credit toward degree programs, as well as certificates for DAU courses. They have a total of 120 partners which are comprised of:

1. Defense Contracting Industries such as Boeing; Lockheed Martin, etc.
2. Professional Associations that accept DAU certification courses

3. Government Institutions – Defense Information Systems Agency; Defense Logistics Agency; Federal Acquisition Agency
4. Federal agencies – Department of justice; Department of State
5. Colleges and Universities that provide programs to meet the needs of federal employees in Acquisitions, Technology and Logistics (AT&L) career fields and will accept their certification courses for college credit.

3. RESPONSIBILITIES

a. **Grantham University** will maintain national accreditation through the Distance Education and Training Council.

(1) Provide academic instruction and related professional educational services to accommodate the requirements of students in the academic programs offered. Programs offered by GU under this memorandum include those offered by GU as identified at Attachment One to this memorandum. Educational credit earned through successful completion of courses and programs of instruction at DAU may be transferred to GU degree programs as transfer or elective credit consistent with current GU credit transfer policies.

(2) GU will also consider for acceptance as transfer or elective credit all other courses of instruction conducted by DAU for which a student petitions to apply to a program of study offered by GU, on a course by course basis. DAU courses comprising programs of study are categorized at Attachment Two. The transfer credit evaluation matrix is included at Attachment Three.

(3) GU will accept all academically qualified individuals as defined in the current GU catalog for admission and will enroll them in desired courses and programs. Upon receipt of an application for admission and request for evaluation the university will evaluate applicable transfer credits. Credits approved for transfer, including those recommended by the American Council on Education and based on resident study, written examinations or other educational experiences, will be applied to degree programs articulated through agreement with DAU, consistent with GU policies and procedures.

(4) GU will provide an opportunity for students to purchase textbooks and other required course materials or instructional equipment prior to the beginning of each course at the same prices for which they are available to all other similarly situated students.

(5) GU will ensure all students are provided complete GU financial aid information to include tuition rates, other costs, available scholarships, and any other information available to the school and applicable to the potential student.

(6) All GU faculties will be available to students at time periods other than during class to enable academic consultation and instruction between students and course instructors.

(7) GU will keep complete and accurate records of all academic work completed or attempted by each enrolled student and will make such information available on school transcripts of academic records in accordance with GU policies.

(8). GU will maintain an on-going academic relationship with DAU for the purpose of modifying, improving and expanding the programs and services provided for herein as well as coordinating on additional programs and services that may be included under this memorandum or covered under a separate documentation of agreement.

b. **Defense Acquisition University** will confer with Grantham University on a recurring basis to ensure the successful specific refinement of programs, services and academic articulation resulting from fundamental understanding enunciated in this memorandum.

(1) The curricula of the above mentioned academic collaboration may include the development of unique and distinctive certificate and degree programs designed to provide higher education support to primary areas of expertise developed at and through DAU programs of study.

(2) Such academic collaboration may also include cooperative conferences, seminars, consortia and symposia conducted at various campus locations of GU and/or DAU or other locations as agreed.

(3) The DAU will assist Grantham University in the distribution of information and in ensuring adequate publicity regarding the academic opportunities available to DAU students that are inherent in programs offered by GU.

(4) DAU will place GU transfer information on their Internet home page and will update that information as changes occur.

(5) DAU will work with GU to establish academic terms; term lengths and required course dates that are offered at times that are flexible and convenient to the majority of DAU sourced students.




